I understand that BCGA and Landowner (collectively, the "Released Parties") shall have no responsibility to pay for medical treatment and related costs if I am injured. I further understand and agree that any Airstrip is provided for use "as is", and that the Released Parties disclaim all warranties, express or implied, including warranties of merchantability and fitness for a particular purpose of an Airstrip.

Knowing the risks described above, I agree, personally and on behalf of my family, heirs and personal representative(s), to assume all the risks and responsibilities surrounding my use of any Airstrip and participation in the Program.

To the fullest extent allowed by law and equity, I AGREE TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Released Parties, their respective officers, directors, staff, volunteers, employees and agents, and TO RELEASE AND INDEMNIFY THE RELEASED PARTIES from and against any and all liability for any damage, expense or injury including death that I may suffer, or that my next of kin may suffer, resulting from or arising out of any aspect of my use of the Airstrip and/or my participation in the Program, RESULTING FROM ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF STATUTORY DUTY OF CARE, INCLUDING ANY DUTY OWED UNDER THE OCCUPIERS LIABILITY ACT, R.S.B.C. 1996, c.337, AND REGARDLESS OF FAULT, in respect of the Airstrip and/or Program, or in respect of the provision of or the failure to provide any warnings, directions, instructions regarding the Airstrip or the risks, dangers and hazards of flight activities and/or the Program and/or the Airstrip.
